This includes all memberships received and expiring before 31st August 2020 (£8,090). Roughly £42,000 left in fundraising money pot for buildings, even though this does not show in accounts due to various commitments. GS would like to show restricted fund but accountant advised that this is something that should not be done. Less than £10,000 in bank which is free for spending. There is no major money to spend on the roof. Question on responsibility for Wessex bill. Gallery previews: - wine sold is charged to the exhibitors at cost. Should we be making a little profit? KB suggested that they would go elsewhere to buy the wine. Should we give exhibitors the choice? If Jerome is happy to buy the wine we can continue. He needs to be asked. Discussion ensued.
